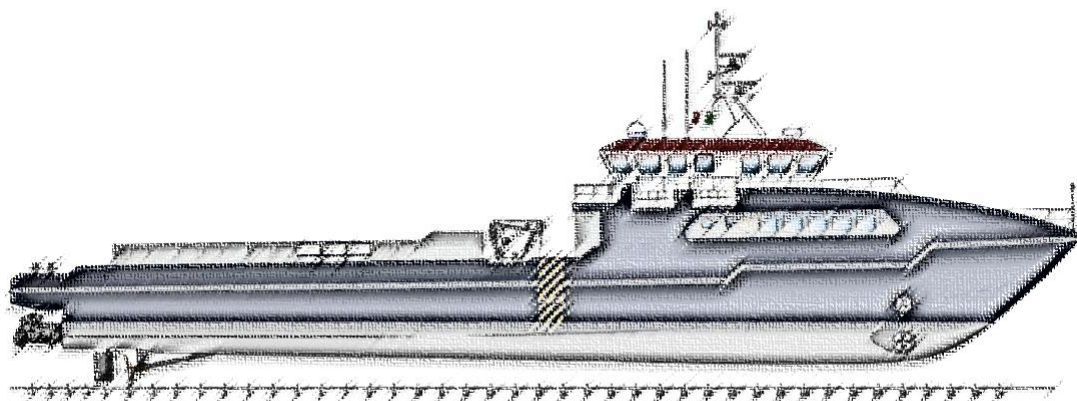

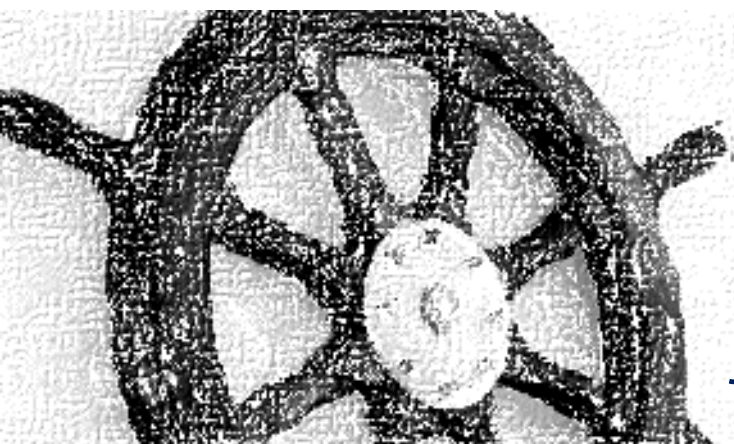
In 2014 the Company obtained certification of compliance with international standards **ISO-14001** and **ISO 45001**.
